- Ms. Lewis is resigning from the Board. The Board has re-aligned their positions and the new roles are listed as approved.

**Landscape Committee:** Ms. Doumas reported that they have not seeded Alder Woods yet, but that it is on the schedule for the end of August/ September.

Nova Tree experts are willing to come through 1x month to evaluate the trees in the community at no cost.
