APPROVAL OF MINUTES

- Management will request that the wood chips from the next round of tree work be placed in select areas.
- Garland Tree Ct. stop sign is down. Will need to be replaced.
- Corkwood Mailboxes: The flagstones are not level. Management will investigate proposals to repair/ replace.
- Towing report is attached in the Board packet for the Boards review.

COMMITTEE UPDATES:

Landscape Committee: Ms. Doumas said that the committee had approved for Blade Runners to install and water eight new flowering trees as well as one Maple tree. NOVA Tree Experts have removed fourteen of the eighteen aged out trees on Alder Woods. Blade Runners will also be delivering flowers for the committee to plant at the entrances

There are three large areas that are overgrown and require clean up. Ms. Doumas will work on getting proposals for that task.

Ms. Duomas is also looking into soliciting a drainage specialist for consult as well as obtaining pricing on a tree maintenance program for the community.

ARB: Mr. Winograd reported that there had been a few architectural requests and that they are anticipating a surge in requests in the coming months.

EVENTS: Ms. Gilmore said that the events committee had received the first registration for the yard sale.
